ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is COMPLETE MEDICAL SERVICES OF SOUTH
FLORIDA, INC.

ARTICLE II - DURATION

The Corporation shall have perpetual existence commencing on the dates these Articles of
Incorporation are filed with the Florida Secretary of State's Office.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the
United States and the State of Florida.


