ARTICLES OF INCORPORATION

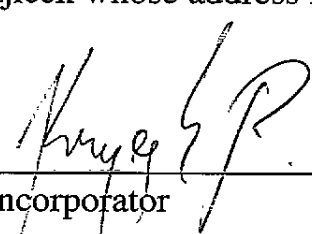
The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

1. The name of the corporation is: **KR2002 CORP.**

7. The incorporator of this corporation is Roman Krajicek whose address is 1165 Crystal Way #G, Delray Beach, FL 33444.

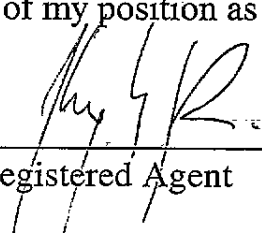
