**ARTICLES OF INCORPORATION  
OF  
JAMES M. PORCELLI, M.D., P.A.**

I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

**ARTICLE I - NAME**

The name of this corporation shall be: JAMES M. PORCELLI, M.D., P.A.

**ARTICLE II - PRINCIPAL PLACE OF BUSINESS**

The principal place of business of this corporation shall be:

**ARTICLE III - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE IV - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business in the Practice of Medicine, under Chapter 607, Florida Statutes, as now exists or may after be amended.




