ARTICLES OF INCORPORATION OF BG&M PROPERTIES, INC.

The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME

The name of this corporation is: BG&M Properties, Inc.
