**ARTICLE I**

The name of the corporation is E.H. HOSBACH PLUMBING, INC..

**ARTICLE II**

This corporation shall have perpetual existence, and shall commence upon the signing and acknowledging of these Articles.



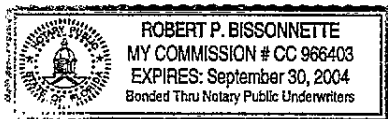
