ARTICLES OF INCORPORATION

OF

JEFFERSON ENTERPRISES, INC.

I, the undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

Name of Corporation

The name of this corporation is JEFFERSON ENTERPRISES, INC.

ARTICLE II

Principal Office
