

ARTICLE ONE

The name of the corporation is OILFIELD EXPEDITORS, INC.. The principal office of the corporation is 3800 Josie Lane, No. 3, Palm Harbor, Florida 34685.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida Corporation Act.

The Board of Directors is empowered to make, alter or repeal the bylaws of the corporation without restriction of their powers conferred by statute.




