The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida:

ARTICLE I - NAME

The name of the corporation is SGS of North Florida, Inc., and the principal office address and mailing address of the corporation is 3551 St. Johns Avenue, Jacksonville, Florida 32205.

ARTICLE - DURATION

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles or on the date of filing of these Articles with the Department of State of the State of Florida in the event these Articles are not filed within five (5) days, exclusive of legal holidays, after execution and acknowledgment.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States or the State of Florida.

ARTICLE V - REGISTERED OFFICE AND AGENT

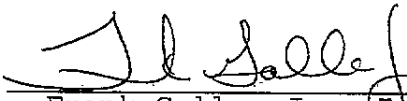

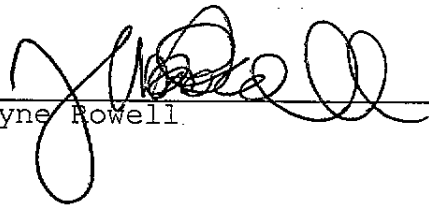
