ARTICLES OF INCORPORATION

OF

I AMA CORPORATION

The undersigned, acting as the incorporator of this Corporation under the Florida Business Corporation Act, and in compliance with Chapter 607 and/or Chapter 621, F. S. (Profit), adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME OF THE CORPORATION

The name of this Corporation shall be **I AMA CORPORATION**

ARTICLE II

PRINCIPAL OFFICE

The Principal Office of the Corporation shall be located at **600 North Highway 17-92, suite 100, Longwood, Florida 32750.**

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

AUTHORIZED SHARES
