

ARTICLE I-NAME

The name of this corporation is MARK KLEMPNER, D.C., P.A.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of conducting chiropractic medical services, and transacting any and all lawful business permitted under the laws of Florida.

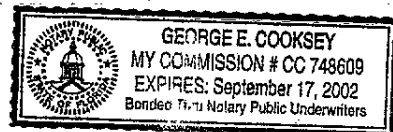
