ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Bluewater Center, Inc., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Florida Department of State.


