ARTICLES OF INCORPORATION

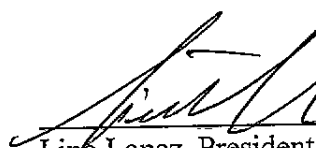
Article VII – Indemnification

Article VIII – Amendment

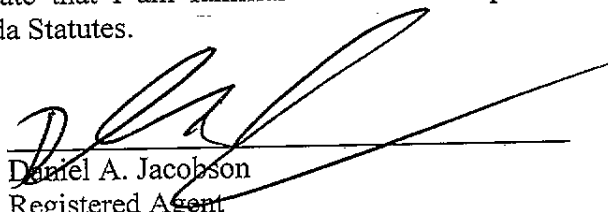
