Please be advised that I never received the annual report for above corporation.

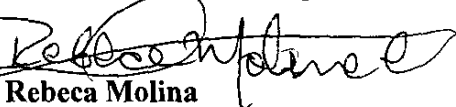
This corporation changed address and ownership and I was not advised that corporation was not renewed or needed to be renewed.
