NAME

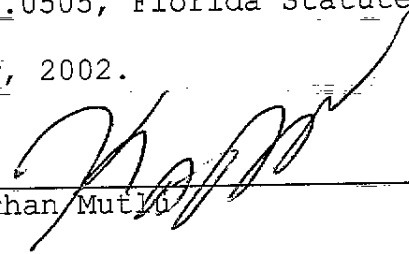
