The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The Name of the corporation shall be: Godwin Faith Enterprises, Inc.

ARTICLE II PRINCIPAL OFFICE

2401B S. Orange Blossom Trail, Orlando, FL 32805

ARTICLE III PURPOSE

The purpose for which the corporation is organized is as follows: Godwin Faith Enterprises, Inc., shall be, but not limited to, a Automobile Repair company, that may also transact any other lawful businesses, for the welfare and benefit of said corporation for which corporations may be incorporated, and governed by and under the laws of the State of Florida and the United States of America.
