The undersigned, for the purpose of forming a corporation under the Florida General Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of this corporation is **MILLER CUSTOM CREATIONS, INC.**

**ARTICLE II  
PURPOSE**

This corporation is organized for the purpose of creating construction alternatives, remodeling, rehabilitating properties, designing, improving and maintaining property, as well as all other related activities permitted under the laws of the State of Florida and the United States of America.

**ARTICLE III  
CAPITAL STOCK**
