These Articles of Incorporation are made and acknowledged by the undersigned Incorporator for the purpose of creating a domestic corporation for profit in accordance with §607.0202 Florida Statutes.

ARTICLE I

The corporate name of the corporation shall be SEVENSTAR YACHT TRANSPORT, INC.

ARTICLE II

The address of the principal business office of the corporation shall be 14411 Commerce Way, Suite 410, Miami Lakes, Florida 33016. The mailing address shall be the same.

ARTICLE III

The corporation is organized to engage in any lawful act or activity for which corporations may be organized under the provisions of the Florida General Corporation Act. Without limitation of the foregoing, it is anticipated that the initial business of the corporation will be the transportation of yachts.


