



OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

The name of this corporation is Anna's Wine Shop, Inc., and its principal office is located at 424 ½ South B Street, Pensacola, Florida 32501, and its mailing address is the same.

**ARTICLE II
DURATION**

This corporation shall exist perpetually, commencing upon the date of subscription and acknowledgment of these Articles of Incorporation.


