ARTICLE I

Name

The name of this corporation is:

ARTICLE II

Purpose

The general nature of the business or businesses to be transacted is to own and operate a laundry business and to do all and everything necessary and proper for the accomplishment of the objects necessary or incidental to the benefit and protection of the corporation, and to transact any lawful business and to exercise all powers granted to corporations by the laws of the State of Florida.

ARTICLE III
