ARTICLES OF INCORPORATION

OF

5th Avenue Financial Services, Inc.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is 5th Avenue Financial Services, Inc. and its principal office and mailing address is: 1008 Goodlette Road North, Suite 202 Naples, FL 34102.

<u>ARTICLE II - NATURE</u>

The nature of the business to be transacted by this corporation is: financial services. To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same.
