## ARTICLE OF INCORPORATION FOR DEZ, MAHAN, AND CHENNAULT, INC.

The undersigned, for the purpose of forming a corporation under Chapter 607, Florida Business Corporation Act, do hereby adopt the following articles of

incorporation:

## ARTICLE ONE - NAME

The name of this corporation shall be Dez, Mahan, and Chennault, Inc.

## ARTICLE TWO - TERM OF EXISTENCE

The duration of this corporation is perpetual.

## ARTICLE THREE - ORGANIZATIONAL PURPOSE

The purposes for which this corporation is organized are as follows:

- 1. To engage in the business of Roofing, Water Proofing, and Coating as defined in Florida Statute 489.105(e).
- 2. To engage in or transact any other lawful business for which corporations organized under Chapter 607, Florida Business Corporation Act, may be permitted to so engage, and which the Board of Directors of the corporation have decided to be advantageous to engage in, either in connection with the foregoing purpose or otherwise unconnected thereto.
- To do such things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

#### ARTICLE FOUR - STOCK

The aggregate number of share that the corporation is authorized to issue is One Million (1,000,000). Such shares shall be of a single class and shall have a par value of \$1.00 (one dollar) per share.

## ARTICLE SEVEN - OFFICE AND PLACE OF BUSINESS

The initial office and place of business of this corporation is 8364 Galewood Circle, Tampa, Florida, 33615.

### ARTICLE EIGHT - PREEMPTIVE RIGHTS

Each shareholder of this corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the par value thereof, a prorata portion of any stock the corporation may issue six months after date of incorporation and not inconsistent with Florida Statute 607.0630.

#### ARTICLE NINE - STOCK TRANSFERS

No stockholder shall have the right to sell, assign, pledge, encumber transfer or otherwise dispose of any shares of the stock of this corporation without first offering such shares for sale to the corporation at their fair market value which shall be set by the Board of Directors. Such offer must be in writing and shall be sent by registered mail to the corporations principal place of business and address to the President of this corporation, and said offer shall remain open for a period of 60 days from the date of mailing. If the corporation fails or refuses to act or make arrangements for the purchase of said stock, within the specified time, the shareholder may then disposes of his shares as he may see fit.

#### <u> ARTICLE TEN – CUMULATIVE VOTING RIGHTS</u>

The principal of cumulative voting shall apply in all elections of Directors of this corporation. Each stockholder entitled to vote shall be entitled to vote the total number of votes equal to number of shares having voting rights multiplied by the number of Directors to be elected, and each may east all votes for a single candidate or may divide

and distribute such votes among any two or more candidates as the stockholder may see

#### ARTICLE ELEVEN - ASSESSMENT

There shall be no power to levy any assessment on any shares of the stock of this corporation.

## ARTICLE TWELVE - INDEMNIFICATION

This corporation shall indennify its, Directors, officers, employees, agents, and shareholders against any threatened, pending or completed action, suit, or proceeding, whether civil or criminal, administrative or investigative, by reason of their association with or employment by this corporation. Such indemnification shall be broadly construed and to the fullest extent permissible under Florida Statute 607.0850.

#### ARTICLE THIRTEEN- CLOSELY HELD CORPORATION

This corporation is authorized to issue only one class of stock, and not more than ten (10) persons shall hold all issued stock of record. Stock shall be issued and transferable only to natural persons who are not nonresident aliens.
