ARTICLE ONE

The name of this corporation is VAML, INC. and the mailing address of the corporation shall be 11424 Waterford Village Drive, Fort Myers, FL 33913.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.
