ARTICLES OF INCORPORATION (PROFIT)

1. The name of the Corporation shall be: Classique Catering Inc.
2. The number of shares the corporation is authorized to issue shall be 100 shares all of one class designated as common stock, at \$ 1.00 per value.
3. The street address and county of the initial principal office of the corporation is 13416 SW 13 Ln, Miami, FL 33184 Miami-Dade County and the name of the initial registered agent at this address is Luis A. Carballosa, residing at 13416 SW 13 Ln. Miami, FL 33184
4. The number of directors constituting the initial board of directors shall be one director and the name and address of the person who is to serve as director until the first meeting of shareholders or until his successors are elected and qualified are:
  - 1) Luis A. Carballosa, President, Vice-President, Treasurer and Secretary, residing at 13416 SW 13 Ln., Miami, FL 33184 Miami-Dade County.
5. To the fullest extent permitted by the State of Florida Business Corporation Act as it exists or may hereafter be amended, no person who is serving or who has served as a director of the corporation shall be personally liable to the corporation or any of its shareholders for monetary damages for breach of duty as a director. No amendment or repeal of this Article nor the adoption of any provision of these Articles of Incorporation inconsistent with this Article shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal, or adoption.
