INCORPORATION AGREEMENT AND ARTICLES

1. **Shareholder's Name.** Ligia M. Suarez (the Shareholder), agrees to the following terms and conditions: The Shareholder will form a corporation under the state of Florida law using the Articles of Incorporation described below:

ARTICLE 1 - CORPORATE NAME:

The Corporation will be called ACCOUNTING CONNECTIONS, CORP.

ARTICLE 2 - PRINCIPAL OFFICE:

The principal place of business/mailling address is: 10627 SW, 79 Terrace, Miami, Fl 33173-2911.

ARTICLE 3 - CORPORATE PURPOSE:

The principal corporate purpose will be the performance of all activities related to the formation, management, administration, and contability of businesses.
