The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, and each of whom are licensed or otherwise legally authorized to render the professional services herein described, hereby associate themselves together to form a professional service corporation under Chapter 607 of the Laws of the State of Florida.

ARTICLE I NAME AND ADDRESS

The name of the corporation is Bread & Nails Inc The principal business address of the corporation is in care of 1812 SE 37 ter CAPE Coral FL 33904

ARTICLE II NATURE OF BUSINESS

This corporation may engage in each and every aspect of Bread & Nails Inc but only through its officers, employees and agents who are authorized to render such services; and engage in any and every other activity permitted from time to time for a corporation so formed to engage in.

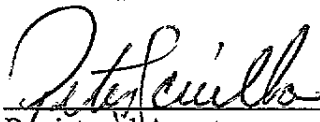
