
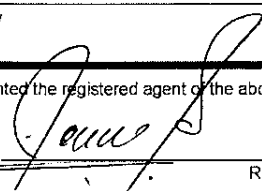
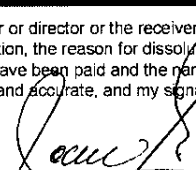

We have never received the 2004 Uniform Business Report. We think it was sent to a different location.

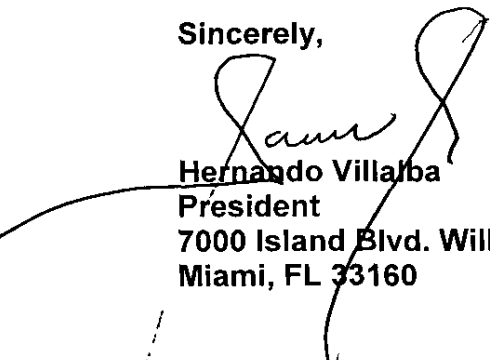
