

**ARTICLES OF INCORPORATION
OF
AMERICAS MAJESTIES, INC.**

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I: NAME

The name of the Corporation is Americas Majesties, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 4990 Coquina Key Drive, St. Petersburg, Florida 33705.

ARTICLE III: CAPITAL STOCK

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 1,000 shares of common stock with a par value of \$1.00 per share. Each share of said stock shall entitled the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation. ARTICLE IV: REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office of this corporation shall be located 4990 Coquina Key Drive, St. Petersburg, Florida 33705 and the initial registered agent of this corporation at such office shall be Fletcher E. Morgan. This corporation shall have the right to change such registered agent and such registered office from time to time, as provided by law.

The term of existence of this corporation is perpetual.


ARTICLE IX: BY-LAWS
