ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

NAME

The name of the corporation is BARGUYAM INVESTMENTS, INC.

ARTICLE II

DURATION

EFFECTIVE DATE  
07-30-02

The period of duration of the corporation is perpetual. Corporate existence shall commence on the date these Articles are executed and acknowledge, except that if they are not filed by the Department of State of the State of Florida within five (5) days, exclusive of legal holidays, after they are executed and acknowledge, corporate existence shall commence upon filing by the Department of State.

ARTICLE III

PURPOSE

The purpose for which the corporation is organized is to transact any and all lawful business, and to engage in any activity within the purpose for which corporations may be organized under the Florida General Corporation Act.

## ARTICLE IV

### CAPITAL STOCK

(a) Authorized Capital: The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having no par value.

(b) Preemptive Rights: Shareholders shall have no preemptive rights.

(c) Cumulative Voting: Cumulative voting shall not be permitted.

## ARTICLE V

### INITIAL REGISTERED OFFICE AND AGENT

#### PRINCIPAL BUSINESS ADDRESS

The street address of the initial registered office of the corporation is Vernis & Bowling, P.A., 1680 N.E. 135<sup>th</sup> Street, North Miami, Florida 33181 and the name of the initial registered agent of the corporation is Manuel A. Avila, Esq. The principal business address of the corporation is 1025 N.E. 147 Street, North Miami, Florida 33161.

## ARTICLE VI

### BY - LAWS

The initial by-laws of this corporation shall be adopted by the directors. By-laws may be adopted, altered, amended or repealed from time to time by either the shareholders or the Board of Directors, but the Board of Directors shall not alter, amend, or repeal any By-laws adopted by the shareholders if the shareholders specifically provide that such By-laws shall not be altered, amended or repealed by the Board of Directors.

## ARTICLE VII

### DIRECTORS

The initial Board of Directors shall consist of four members, who need not be residents of the State of Florida or shareholders of the corporation.

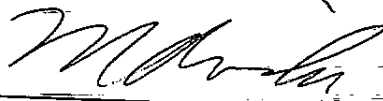

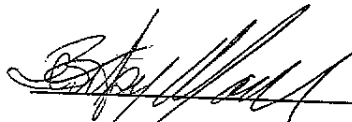
