ARTICLES OF INCORPORATION OF

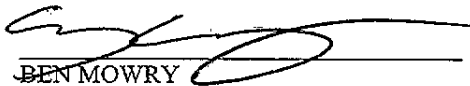

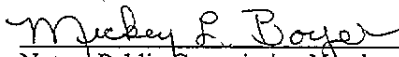

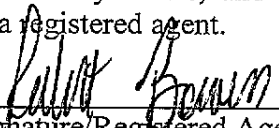
