ARTICLES OF INCORPORATION

OF

FUTURE GOLD, INC.

(a Florida Not For Profit Corporation)

We the undersigned, acting as incorporators of a corporation pursuant to Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for the corporation:

Article I: Name

The name of the corporation shall be Future Gold, Inc.

The business address of the corporation at the time of incorporation is 616 N. Ridgewood Avenue, Edgewater, Florida, 32132, and the mailing address of the corporation at the time of incorporation is 132 West Park Avenue, #12, Edgewater, Florida, 32132..
