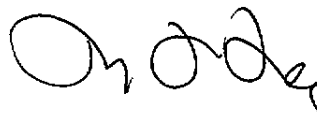

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be: **DEER CREEK REFERRAL NETWORK, INC.**

**ARTICLE II. ADDRESS**
