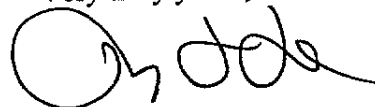

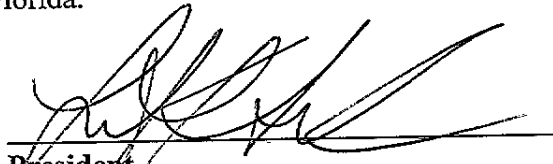
DEER CREEK REFERRAL NETWORK, INC., a Florida corporation, hereby amends

ARTICLE I. NAME

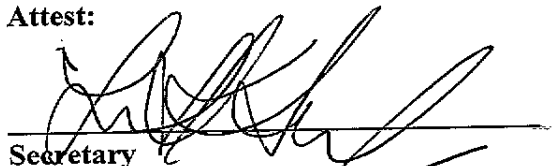
The name of the corporation shall be: PALM PROPERTY MANAGEMENT NETWORK,

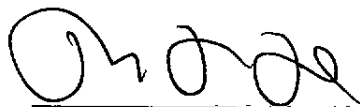
