ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Dial a Fitting, Inc., and its principal place of business shall be located at 4040 N.W. 62nd Lane, Coral Springs, Florida 33067.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of common stock of a par value of One Cent (.01) per share.

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office address of this corporation is 4040 N.W. 62nd Lane, Coral Springs, Florida 33067, and the name of the initial registered agent of this corporation at that address is Clarence E. Lohmann.

ARTICLE VII - DIRECTORS

Initially, this corporation shall have one (1) Director who shall serve until successors have been elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the bylaws. The name and address of the initial director is as follows: Clarence E. Lohmann, 4040 N.W. 62nd Lane, Coral Springs, Florida 33067.

ARTICLE VIII - OFFICERS

The initial officers of the corporation shall be elected at the first meeting of the Board of Directors and shall serve until their successors shall be elected or appointed.

ARTICLE IX - INCORPORATORS

The name and address of the Incorporator signing these articles is: Clarence E. Lohmann, 4040 N.W. 62nd Lane, Coral Springs, Florida 33067.

ARTICLE X - INDEMNIFICATION



This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation. These Articles of Incorporation may be amended at any time by a majority vote of the shareholders.






