ARTICLES OF INCORPORATION of L. D. BEERS, INC.

SECRETARY OF STATE TALLAHASSEE FLORIDA

In compliance with chapter §607 and /or chapter §621 of the Florida Statutes, the undersigned hereby incorporate for profit under the laws of the State of Florida and hereby adopt the following Articles of Incorporation:

ARTICLE I CORPORATE NAME

The name of this corporation is L. D. Beers, Inc.

ARTICLE II INITIAL PRINCIPAL OFFICE

Any director or officer who is involved in litigation or other proceeding by reason of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.
