ARTICLE I

Name and Principal Office

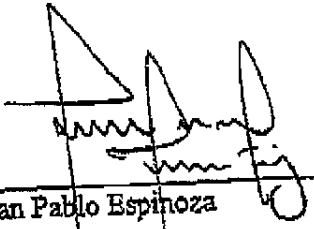

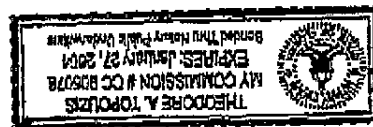
