ARTICLES OF INCORPORATION
OF

ARTICLE I. - CORPORATE NAME

The name of this corporation is Dealer Services of Ocala, Inc.

ARTICLE II. - PURPOSE

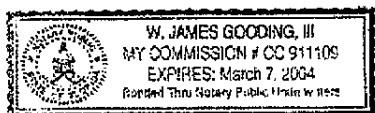


