ARTICLES OF INCORPORATION OF:

F.S.R. PAVERS, INC.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607

Of the Florida Statutes.

ARTICLE I - NAME
