ARTICLE I. CORPORATE NAME

ARTICLE III. CAPITAL STOCK

The aggregate number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is One Hundred Million (100,000,000) shares of common stock having a par value of \$.001 per share. ARTICLE VIII. AMENDMENT


