ARTICLES OF INCORPORATION 99 CENTS GROCERIES, INC.

CILED TO The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of the Corporation shall be 99 CENTS GROCERIES, INC.

ARTICLE II.

PRINCIPAL OFFICE
