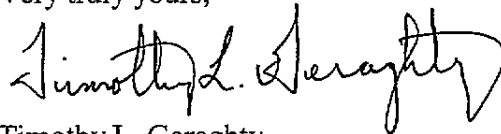

ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or Chapter 621 of the Florida Statutes

ARTICLE I
