
**ARTICLES OF DISSOLUTION

1. The name of the Corporation is: **Courtyards at Nautica - Phase II, Inc.** The Document Number of the Corporation is P02000085140. The filing date of the Articles of Incorporation of the Corporation was August 6, 2002.
