ARTICLE XII - SHAREHOLDER AGREEMENT


The shareholders of this corporation may at any time from time

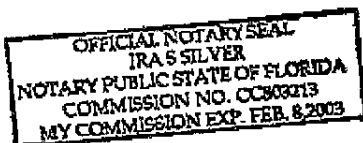
