The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be as follows:

ARTICLE II

The duration of this corporation shall be perpetual effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE III

The purpose of this corporation is the transaction of lawful activities or business permitted under the Laws of the United States and the State of Florida.

ARTICLE IV

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 100 shares of common stock having a par value of 1.00 per share.

Pugh, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process.

The initial Board of Directors shall consist of three members. The number of directors may be increased or decreased from time to time as provided in the By-laws, but in no case shall the number of directors be less than two.
