ARTICLES OF INCORPORATION

OF

ONE NATION OF BILLIONS, INC.

The undersigned incorporator to these Articles of Incorporation, all of whom are duly licensed and competent to contract for performing, writing, producing, signing, recording, releasing, marketing, promoting and distributing music, hereby forms a corporation for profit pursuant to the provisions of the Florida Business Corporation Act and other laws of the State of Florida.

ARTICLE I

Name

The name of this corporation is: **ONE NATION OF BILLIONS, INC.**

ARTICLE II

Existence

The corporation's existence shall commence on August 12, 2002.

ARTICLE III

Nature of Corporate Business and Powers

The general nature of the business to be transacted by this Corporation shall be:

A. To engage in every aspect and phase of the music Industry, including performing, writing, producing and recording of musical acts by means of audio, video and all other mediums, and signing, releasing, marketing, promoting and distributing various groups and other talent, and all related services authorized to render .

B. To invest and reinvest the funds of this corporation in real estate, mortgages, stocks, bonds of any other type of investments within the meaning of Chapter 621.08, Florida Statutes, and to acquire and own real and personal property necessary for the rendering of professional services.

C. To do each and every thing necessary and proper for the accomplishment or furtherance of any of the purposes or objects of this corporation enumerated in these Articles of Incorporation, or amendment thereof, necessary or incidental to the protection and benefit of this corporation; and, in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuits necessary or incidental to the accomplishment or furtherance of such purposes or objects of this corporation.

D. To conduct and transact any business lawfully authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be amended from time to time.

ARTICLE IV

Authorized Capital

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 (100) shares of common stock having a par value of five (\$5.00) Dollar per share.

Shares may be issued only for a consideration having a value, in the judgment of the Board of Directors, at least equivalent to the full par value of the stock to be issued. All shares issued shall be fully paid and nonassessable.

ARTICLE V

Term of Existence

This corporation shall have perpetual existence.
