The undersigned subscriber to these articles of incorporation, being duly licensed to sell real estate under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, Florida Statutes Chapter 621, and other laws of the State of Florida.

ARTICLE I

Name

The name of the corporation is Susan Katherine Adlman, P.A.

ARTICLE II

Principal Office

The principal office and mailing address of this corporation is 4009 Sioux Circle, Jacksonville, Florida 32259.

ARTICLE III

Purpose
