ARTICLE I-NAME

The name of this corporation is Christel Silver, P.A.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.


#### ARTICLE IX—INDEMNIFICATION
