**ARTICLE X - ACTION WITHOUT A MEETING**

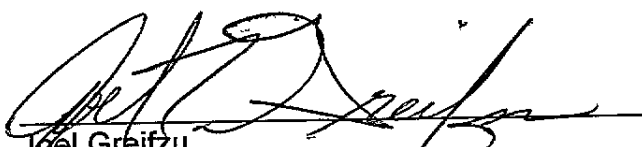
