The name of this corporation is MUNOZ & D., INC.

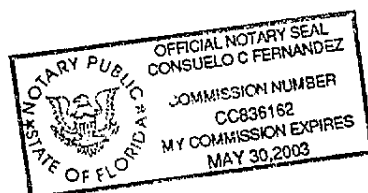

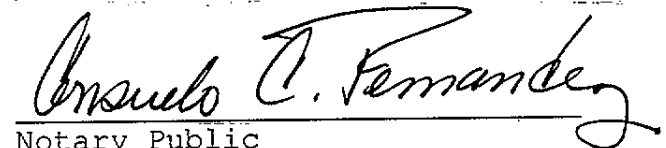
