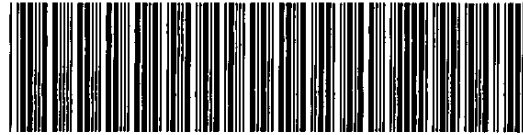




Affective January 1, 2007, VanquishTech Corp.'s board of directors took the resolution to terminate the corporation indefinitely.
