**ARTICLE I - NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is **PREMIER MANAGEMENT SERVICES, INC. OF WEST PALM BEACH**, and its principal place of business shall be located at c/o 1984 Fox Court, Wellington, Florida 33914.

**ARTICLE II - DURATION**
